- Sculptor Capital LP (“Sculptor”), a Delaware limited partnership, is the principal investment manager to a number of investment funds and discretionary accounts (collectively, the “Accounts”).
  - Sculptor Capital Holding Corporation (“SCHC”), a Delaware corporation, serves as the general partner of Sculptor. The Common Stock reported in this Schedule 13G are held in the Accounts managed by Sculptor.
  - Sculptor Capital Management, Inc. (“SCU”), a Delaware limited liability company, is a holding company that is the sole shareholder of SCHC.
  - Sculptor Master Fund, Ltd. (“SCMF”) is a Cayman Islands company.
  - Sculptor Special Funding, LP (“NRMD”) is a Cayman Islands exempted limited partnership.

As such, SCHC may be deemed to control Sculptor and, therefore, may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G. SCU is the sole shareholder of SCHC, and, for purposes of this Schedule 13G, may be deemed to be the beneficial owner of the Common Stock reported in this Schedule 13G.

The percentages used in this Item 4 are calculated based on the Issuer's outstanding 37,500,000 Units as of October 21, 2020 (as described in the Issuer's Prospectus dated as of October 20, 2020, under Registration Nos. 333-249274 and 333-24957, per Form 424B4 filed October 22, 2020). Included in the Units are 30,000,000 shares of Class A common stock.
